CROWD CONTROLLER

To qualify for a Queensland unrestricted Crowd Controller License, you must hold a current Security Officer License or CPP20207 Certificate II in Security Operations plus successfully complete the following units of competency.



CPPSEC2012A Monitor and control individual and crowd behaviour

CPPSEC3002A Manage conflict through negotiation

CPPSEC3003A Determine response to security risk situation

CPPSEC3007A Maintain security of environment

CPPSEC3013A Control persons using empty hand techniques

CASH IN TRANSIT

A cash transit officer carries cash, bullion, jewellery or valuables. Officers who carry a weapon while working must also apply to the Queensland Police Service for the appropriate weapons license.



To obtain a License as a Security Officer (Cash in Transit) you will require an existing Security License or CPP20207 Certificate II in Security Operations plus successfully complete the following units:

CPPSEC3002A Manage conflict through negotiation

CPPSEC3007A Maintain security of environment

TLID4107C Undertake cash in transit loading and unloading in an unsecured environment

TLIO807C Implement cash in transit procedures

TLIO907C Test and inspect cash in transit security equipment

Individual training programmes are discussed with students prior to commencement.

On enrolment each student is sent their own comprehensive Training Manual and Student Workbook by overnight Australia Express Post Satchel.

Training is generally based on a distance learning structure which includes self paced learning complemented by individual one on one tutorials. This training is complemented by a practical surveillance exercise where you undertake actual surveillance on a target in a controlled environment.

Good computer skills are a pre requisite.

All of our Investigation Instructors have extensive Police Investigative and Surveillance experience and are experienced trainers who hold national training qualifications.

On successful completion of the training students are awarded Certificate III in Investigative Services and are eligible to apply for a Queensland Private Investigator's License.
